#### Sara McCurdy Murphy, BA - Project Coordinator



## **Overview of the Site Activation Process**

NARCRMS welcomes MS Centers from both academic medical centers and private practices across the United States and Canada to become enrolling sites for NARCRMS. Sites enrolling in NARCRMS are asked to enroll 50 patients. Included below are instructions for becoming a site for NARCRMS.

- Contact NARCRMSOps@s-3.com to express your interest in becoming an enrolling sites for NARCRMS.
- ♦ Upon approval from NARCRMS Leadership to become an enrolling site, you will receive the following documents:
  - \* NARCRMS Protocol
  - \* NARCRMS Sample Informed Consent and HIPAA Authorization Form
  - \* NARCRMS Clinical Center Agreement (CCA)
  - \* NARCRMS Standard Operating Procedures
- ♦ Submit the NARCRMS CCA to your institution for review, approval and signature. Return the signed CCA to NARCRM-SOp@s-3.com for execution.
- ♦ Submit the NARCRMS Protocol and Sample Informed Consent & HIPAA Authorization form to your local IRB for review and approval. Several NARCRMS sites have utilized Western IRB (a central IRB) instead of their local IRB. Please notify NARCRMSOps@s-3.com if you plan to use Western IRB instead of your local IRB.
- After receiving IRB approval and executing the CCA, please notify and submit a copy of your IRB approval to NARCRMSOps@s-3.com.
- ◆ The NARCRMS Coordinating Center will then schedule a Open Clinica training session for your site so that you are able to begin enrolling patients in NARCRMS.

## **NARCRMS Enrollment Update**

NARCRMS is currently enrolling patients at 6 MS Centers. Included below is a summary update of enrollments as of May 12, 2017.

## Goals of NARCRMS:

Over the next few years, NARCRMS plans to :

- Activate an additional 14 sites for enrollment
- ♦ Enroll at least 1,000 patients across 20 sites
- ♦ Activate Cores of Excellence, including:
  - \* Neuroimaging Core
  - \* Biomarker Core
  - \* Genetics Core
  - \* Bioinformatics/
    Biostatistics Core
  - Neuropathology and Brain Banking Core
  - \* Healthcare Economics Core
- Provide patients enrolled in NARCRMS with a comprehensive picture of their experience in relation to other MS patients.
- Provide an infrastructure for industry supporters to better enroll and conduct clinical trials.
- Provide clinicians with a better understanding of the impact of treatment modalities on disease progression.
